1. Overview

The Single Window System is a centralized digital platform designed to streamline and simplify the process of obtaining approvals, clearances, and services required by businesses and industries. It enables faster decision-making, improves transparency, and reduces delays by allowing applicants to submit and track applications through a single interface.

Purpose: This document serves as a step-by-step guideline for industrial users and departmental officers navigating the Technical Patent Subsidy process within the Department of Commerce and Industries, Chhattisgarh, through the Single Window Portal.

2. How to Get Started

Enter the application URL (<https://oneclick.cgstate.gov.in>) in the browser and the page navigates to the Home page of the SWS application.

3. How to Login




Figure 3.1: Homepage Screen

The user to login with the credentials into the application in the home and login page as a **Figure 3.1 & 3.2.**

The Login page (as shown in **Fig. 3.3**) offers two login methods: **Login with Password** or **Login with OTP**. Choose your preferred option, then enter either your password or the OTP number to proceed.

4. Dashboard




Figure 4.1: Dashboard Screen

After a successful login, the page navigates to the Investor Dashboard (refer to **Fig. 4.1**), which includes step-by-step instructions for adding new unit details.




Figure 4.2: Incentives Screen

On the Incentives page, refer to **Figure 4.2**, which displays all incentives. In the Application section, select the option to apply for Technical Patent Subsidy.

5. Technical Patent Subsidy

- The user can apply for the Technical Patent Subsidy only after obtaining a Production Certificate.
- This incentive can be availed for multiple times irrespective of any conditions.
- The "Priority Sector" field will be displayed only if the "Category of Entrepreneur" is selected as "Thrust."
- If not already uploaded, the user must upload the required documents to the Entity Vault.
- Information retrieved from the Production Certificate form on this page is non-editable. To make any changes, the user must update the original Production Certificate form.

5.1. Technical Patent Application Form

After clicking the 'Apply' option, the 'Application for Technical Patent Subsidy' screen is displayed, as shown in Figure 5.1.

Click on **I Agree** option and **Proceed** for application process

Or, click on **I Don't Agree** option and then **Proceed**

In Figure 5.2, **Is it a Startup Industry?**

- Select **Yes** if the unit is a startup.
- Select **No** if the unit is not a startup.

Startup Certificate Details (If "Yes" is selected)

- **Startup Certificate Number:** Enter the startup certificate number.
- **Startup Certificate Issue Date:** Select the date the startup certificate was issued.
- **Certificate Issued By:** Choose the authority that issued the startup certificate.

5.1.1 User enter the Patent and Research Details

- **Patent Registration No.:** Enter the unique registration number for your patent.
- **Name of the Registration Authority:** Provide the full name of the authority that registered the patent.
- **Receiving Date:** Use the calendar tool to select the date you received the certificate.
- **Patent / Research Approval Details:** In this field, provide specific details about the approval of your patent or research.
- **Expenditure in Obtaining Patent / Research:** Enter the total amount spent to obtain the patent or conduct the research.
- **Claimed Amount (in Lakh):** Enter the amount you are claiming in lakhs.




Figure 5.5: Successful Pop-up Screen

Upon successful submission of your application, a confirmation pop-up will appear on your screen, as shown in **Figure 5.5**.

- On clicking the submit button, the response is submitted.




Figure 5.6: Share Your Feedback

Get navigated back to the dashboard section.




Figure 5.7: Dashboard Screen





Figure 5.8: Incentives Screen

On the Incentives page (refer to Figure 5.8), all incentives are displayed. The user can check the submitted application details.

In the **Application Details** section, the user can view the list of incentives they have applied for and select the Technical Patent application to check the submitted application, track its status, and download the certificate after approval.




