1. Overview of Boiler Services

This software solution is designed to streamline the management of industrial and commercial boiler services. It aims to improve safety, efficiency, and compliance by digitizing workflows and automating key functions. The system will provide real-time monitoring, maintenance scheduling, and detailed reporting to ensure the continuous and optimal operation of boiler systems.

Purpose of Boiler Manufacturer Registration: The Boiler Manufacturer Registration module is designed to simplify and manage the registration and approval process for boiler manufacturers. It serves as a platform for manufacturers to submit their credentials and required documents, ensuring they meet all regulatory standards.

2. How to Get Started

Enter the application URL (<https://oneclick.cgstate.gov.in>) in the browser and the page navigates to the Home page of the SWS application.

3. How to Login

The user to login with the credentials into the application in the home and login page as a **Figure 3.1 & 3.2**.




Figure 4.1: Dashboard Screen

After a successful login, the page navigates to the Investor Dashboard (refer to **Fig. 4.1**), which includes step-by-step instructions for applying services.

5. Boiler Manufacturer Registration

After clicking the apply option, a Boiler Manufacturer Registration Services screen appears in the application, as shown in **Figure 5.1**.

5.1. User enter the Firm Details

- **Name of Industry:** Enter the full name of the industry or company.
- **Address:** Provide the complete address of the industry.
- **Area (Hectare./Acre./Sq.mr):** Specify the total area of the industrial unit.
- **District:** Enter the district where the industry is located.
- **Block/Tehsil:** Enter the block or tehsil.
- **Village/Town:** Enter the village or town.
- **Pin code:** Enter the postal code.
- **Establishment Year:** Select the year the industry was established from the dropdown menu.
- **Classifications applied for:** Choose the appropriate classification from the dropdown list.

- **Max Pressure:** Enter the maximum pressure the boiler can withstand.
- **Temperature:** Enter the operational temperature of the boiler.
- **Material Involve:** Select the materials used in the boiler's construction.
- **Other Details:** Provide any additional relevant information.

5.3. User enter the Other Details

1. Number of Working Sites

- In the text box provided, enter the number of working sites your firm can handle simultaneously.
- **Example:** If your firm can manage 5 sites at the same time, enter "5".

2. Conformity and Standards

- Select the radio button that corresponds to your answer.
- Select 'Yes' if your firm is ready to comply with all regulations and maintain high-quality work.
- Select 'No' if your firm is not able to do so.

3. Responsibility and Clarification

- Select the appropriate radio button.
- Select 'Yes' if your firm is willing to take full responsibility for its work and resolve any disputes.
- Select 'No' if your firm is not.

4. Material Supply and Certificates

- Choose the radio button that reflects your firm's capability.
- Select 'Yes' if your firm can provide materials that meet the specified requirements and include the necessary test certificates.
- Select 'No' if your firm cannot.

5. Upload Form 19:

- Download Form 19 in the field
- Click the "Choose File" or "Upload Document" button.




Figure 5.4: Boiler Manufacturer Registration – Technical & Welder Details



5.5. User enter the Engineer/Technician Details

- **Name:** Enter the full name of the Engineer/Technician in the provided text field.
- **Degree:** Enter the highest academic degree obtained by the Engineer/Technician.
- **Experience:** Enter the total years of relevant professional experience for the Engineer/Technician.

5.6. User enter the Equipment Details

- **Rectifier or Generator:** Enter details for the rectifier or generator.
- **Grinder:** Enter details for grinders available.
- **Dye Penetrant Kit:** Enter details for the dye penetrant kit.
- **Expander:** Enter details for expanders.
- **Measuring Instrument:** Enter details for measuring instruments.
- **Electric Arc Oxyacetylene Welding Sets:** Enter details for welding sets.
- **General Tools and Tackles:** Enter a comprehensive list of general tools.
- **Others:** Use this field to list any additional specialized tools or equipment not covered above.
- **Save:** Click the Save button to submit your completed application.
- **Save As Draft:** Use the Save As Draft button to save your progress and return to the form later.




Figure 5.6: Confirmation Pop-up Message

For the application submitted, the user needs to make payment for the fee charged as per the industry type as Micro, Small, Medium or Large. User has the option to pay fee now or pay later.




Figure 5.9: Confirmation Message
