1. Overview

The Single Window Portal is a unified digital platform designed to provide investors, entrepreneurs, and businesses with simplified, transparent, and time-bound access to a wide range of industrial services and approvals.

Purpose: This document provides a step-by-step guide for eligible industrial units to apply for fixed capital incentives, which include subsidies and benefits on investments in plant, machinery, and other fixed assets.

2. How to Get Started

Enter the application URL (<https://oneclick.cgstate.gov.in>) in the browser and the page navigates to the Home page of the SWS application.

3. How to Login




Figure 3.1: Homepage Screen

The user to login with the credentials into the application in the home and login page as a **Figure 3.1 & 3.2**.




Figure 4.1: Dashboard Screen

After a successful login, the page navigates to the Investor Dashboard (refer to **Fig. 4.1**), which includes step-by-step instructions for adding new unit details.




Figure 4.2: Incentives Screen

On the Incentives page, refer to **Figure 4.2**, which displays all incentives. In the Application section, select the option to apply for Fixed Capital Incentive.

5. Fixed Capital Incentive

- The user can apply for the Fixed Capital Incentive only after obtaining a valid Production Certificate.
- This incentive can be availed multiple times, irrespective of any conditions.
- The "Priority Sector" field will appear only if the "Category of Entrepreneur" is set to "Thrust".
- If the required document has not been uploaded, the user must upload it in the Entity Vault.
- The user cannot edit any information retrieved from the Production Certificate form on this page.
- If any changes are required, the user must amend the details directly in the Production Certificate form.

5.1. Fixed Capital Incentives Application Form

After clicking the 'Apply' option, the 'Application for Fixed Capital Incentives' screen is displayed, as shown in Figure 5.1.

- That I/We shall comply with all terms and conditions, and the competent authority shall have the right to cancel the production/service activity certificate and take appropriate action under relevant laws and rules if any violation is found.




Figure 5.4: Successful Pop-up Screen

Get navigated back to the dashboard section.




Figure 5.6: Dashboard Screen




Figure 5.7: Incentives Screen

On the Incentives page (refer to Figure 5.7), all incentives are displayed. The user can check the submitted application details.
