## 1. Overview

The Single Window System is a centralized digital platform designed to streamline and simplify the process of obtaining approvals, clearances, and services required by businesses and industries. It enables faster decision-making, improves transparency, and reduces delays by allowing applicants to submit and track applications through a single interface.


**Purpose:** This document serves as a step-by-step guideline for industrial users and departmental officers navigating the Project Report Subsidy process within the Department of Commerce and Industries, Chhattisgarh, through the Single Window Portal.

## 2. How to Get Started

Enter the application URL (<https://oneclick.cgstate.gov.in>) in the browser and the page navigates to the Home page of the SWS application.

## 3. How to Login

The user to login with the credentials into the application in the home and login page as a **Figure 3.1 & 3.2.**




**Figure 3.3: Login Screen (B)**

## 4. Dashboard


After a successful login, the page navigates to the Investor Dashboard (refer to **Fig. 4.1**), which includes step-by-step instructions for adding new unit details.

## 5. Project Report Subsidy

- The user can apply for the Project Report Subsidy only after obtaining a Production Certificate.
- This incentive can be availed only once.
- The "Priority Sector" field will be displayed only if the "Category of Entrepreneur" is selected as "Thrust."
- If not already uploaded, the user must upload the required documents to the Entity Vault.
- Information retrieved from the Production Certificate form on this page is non-editable. To make any changes, the user must update the original Production Certificate form.

### 5.1. Project Report Application Form

After clicking the 'Apply' option, the 'Application for Project Report Subsidy' screen is displayed, as shown in Figure 5.1.

Click on **I Agree** option and **Proceed** for application process

Or, click on **I Don't Agree** option and then **Proceed**

- **Claim Amount (In Lakh):** User enter the total claim amount you are requesting, in lakhs.
- **Gross Capital Cost as shown by Project Consultant (in Lakh):** User fill in the gross capital cost as stated by the project consultant, in lakhs.
- **Address:** User enter the complete address.




- Rate the facilities availed by clicking on the Stars provided.

**Figure 5.6: Share Your Feedback**





**Figure 5.7: Dashboard Screen**


On the Incentives page (refer to Figure 5.8), all incentives are displayed. The user can check the submitted application details.

In the **Application Details** section, the user can view the list of incentives they have applied for and select the Project Report application to check the submitted application, track its status, and download the certificate after approval.




